- 1. This is an application for a Town of Bowden Business Licence made under the provisions of the Business Licence Bylaw 03-2017 (as amended over time) to operate a business within the municipality of the Town of Bowden. The licence requirements are stated and defined within the Business Licence Bylaw a copy of which can be obtained by request or by reference to the Town's website.
- 2. It is the responsibility of the Applicant to obtain any relevant or necessary Provincial or Federal licenses, permits, approvals or insurances.
- 3. A Development Permit is required if a business entails new construction or a change in use or intensity of use of present buildings. It is the responsibility of the Applicant to obtain any necessary Development Permits that provide "permitted use" for that business.
- 4. A Business Licence is required for every business operated at each business / residential premise.
- 5. A business operating out of a rental property must have the approval of the property owner.
- 6. Approval and issue of a Town of Bowden Business Licence does not set aside any requirements of the Town's Land Use & Business Licence Bylaws, or the Alberta Environmental Health / Building Code / Occupational Health & Safety regulations.
