### "Igloo" Ice Arena Rink & Wall Board Advertising Agreement

#### Please sign and return this page indicating your acceptance of the terms of this agreement;

- 1. The sign shall conform to the specifications outlined in the "Advertising Confirmation Form" and shall contain only such artwork which has been approved in advance by the Town of Bowden.
- 2. The Town of Bowden will attempt to place the Advertisement within the preferred location requested by the Advertiser. This does not represent or warrant that the Advertisement will be placed in the location requested. The Advertiser agrees that the Town of Bowden may allocate space on a "first come, first served" basis and acknowledges that the Town of Bowden's decision on "location" is final and binding.
- 3. If the Town of Bowden determines the appearance of the sign has deteriorated prior to the expiration of this contract, the Town of Bowden reserves the right to remove the sign and request the Advertiser to replace the sign at the sole cost of the Advertiser.
- 4. The cost of the design, manufacture, and delivery of the advertising sign prior to mounting is the responsibility of the Advertiser.
- 5. The Town of Bowden shall perform all installation and removal of signs.
- 6. The Advertiser agrees that their advertising sign may be temporarily covered by the Town of Bowden, without reimbursement, during national or provincial events (other than local events) and the local Figure Skating Carnival. The Advertiser shall not be entitled to any reimbursement relating to the annual maintenance shutdown or any other temporary or unplanned closure of the Arena
- 7. The sign shall not become the property of the Town of Bowden, and the Town of Bowden shall not bear any responsibility for repairs or maintenance thereto.
- 8. Upon the expiration of the term of the Agreement, the Town of Bowden may remove the sign unless the Agreement has been renewed and the appropriate fee for the new term has been received.
- 9. The Town of Bowden may, without notice, at any time and for any reason remove a sign. The Town of Bowden shall reimburse the Advertiser for the pro-rated amount of the fee for the balance of the term during which the sign is removed. The Advertiser shall not be entitled to any further claims for damages or reimbursement related hereto. No fee reimbursement will be given pursuant to section 3 & 6.
- 10. The Advertiser may apply for approval to renew this Agreement prior to the end of the current Agreement at the rates in effect at that time. Such applications have priority over any non-renewing application.
- 11. It is agreed that neither party shall be bound by any representation, warranty, nor agreement which is not written in the Agreement and that, except as written in the Agreement, the Town of Bowden shall not be responsible for any representation, warranty or agreement which may have induced the Advertiser to enter into this Agreement.
- 12. If the Town of Bowden removed a sign pursuant to sections 3, 8, & 9 above, the Town of Bowden shall have the right to dispose of the sign if it has not been reclaimed by the Advertiser within thirty (30) days after the Town of Bowden gives written notice to the Advertiser for such removal. The Advertiser shall have no claim against the Town of Bowden in relation to such disposal.
- 13. There will be no cancellations by the Advertiser after this Agreement has been signed.
- 14. The Advertiser will deliver all signs to the Town Administration Office prior to installation.
