BYLAW 06-2018**

**A BYLAW TO AMEND BYLAW 03/2007 BEING A BYLAW RESPECTING RATES TO BE CHARGED FOR VARIOUS GOODS AND SERVICES PROVIDED BY THE TOWN OF BOWDEN**

WHEREAS the Municipal Government Act (MGA), Revised Statutes of Alberta 2000, Chapter M-26 and amendments thereto, gives broad authority to Councils and respects their right to govern their municipalities in whatever way the Council considers appropriate. This broad authority includes the power to pass bylaws to establish fees pursuant to Section 8 of the MGA.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE TOWN OF BOWDEN, IN THE PROVINCE OF ALBERTA, DULY ASSEMBLED, ENACTS AS FOLLOWS:

**1. Schedule "A", of Bylaw 03/2007, is amended as follows:**

SCHEDULE 'A' - Utility Rates**

Water Meters	cost + 10%
Meter inspection & testing deposit (only refunded if meter is faulty)	\$200.00
Utility Re-connection fee	\$55.00
(plus, the costs of damage repair & thawing if frozen [GST added])	
Tampering with or operating Utility Shut-Off Valve	\$300.00
Penalty for utility account arrears	8%
Water Services:	
1. Basic Service charge per account per month	\$10.00
2. Water Consumption per m <sup>3</sup>	\$3.00
Sanitary Sewer:	
1. Basic Service charge per account per month	\$5.00
2. Usage fee calculated on the metered water charge per m <sup>3</sup>	\$3.00
Solid Waste Cart Collection (Residential Participation is mandatory – Commercial participation is optional):	
\$11.00 per month per solid waste cart (to a maximum of 3 solid waste carts per unit)	
Recycling Cart Collection (Residential Participation is mandatory – Commercial participation is optional):	
\$11.00 per month per recycling cart (to a maximum of 3 recycling carts per unit)
