Item 6.a 2015 Utility Rates On November 19, 2014 the Water Commission (MVRWS) informed the Town of Bowden that effective April 1, 2015 they would be increasing prices by 5 cents per cubic meter. As well, it has been previously reported to Council that the Sewer Commission (SRDRWC) would likely be connected to the regional sewer system in May of 2015. As such, rates charged to our customers will need to be increased to reflect these new expenses. In essence, water rates will be increased by 5 cents (from \$2.95 to \$3.00 per cubic meter) and on the sewer side, rates will be increased from 90 % of water rates to 100 percent of water rates based on water consumption (from \$2.66 to \$3.00). These increased fees will take effect on April 1, 2015.

Item 6.c Alberta Community Partnership Grant The Alberta Community Partnership (ACP) objective is to improve the viability and long-term sustainability of municipalities by providing support for regional collaboration and capacity building activities, including project implementation costs. On behalf of their regional partners, Red Deer County Community & Protective Services has made an application of \$350,000.00. If successful, the funds will be used to purchase 4 vehicles to support their emergency management & technical rescue teams. To assist with their grant application, Red Deer County is asking for letters of support from their regional partners. This does not mean that Bowden will be required to provide a financial contribution nor does it preclude any future potential regional grant application by Bowden as a managing partner for any other funding area covered by this grant. To provide support, Council is asked to pass a resolution giving support to Red Deer County Community & Protective Services for this grant application.
