Item 6.a Maturing ATB Investment On June 18, 2016 two GIC's will be maturing in the amounts of \$100,000.00. With these monies council can choose to approve that we move the \$200,000.00 into a 90 Day revolving account with interest being paid every 30 days. Accessing the funds would be easier as we would only need to give the bank 30 days' notice.
