4.a Reduction in Number of Councillors

(i) Proposal

A proposal is submitted to Town Council to discuss a reduction in the number of Councillors.

The proposal is to reduce the number of elected Councillors from 6 to 4.

The position of chief elected official (Mayor) would remain thereby providing in total an odd number of elected officials (5 in total).

(ii) Legislative Requirements

Section 143(1) of the MGA states:

The council of a city or town consists of 7 councillors unless the council passes a bylaw specifying an odd number of 3 or more.

Section 151 of the MGA states:

- 151(1) A bylaw under section 143, 148 or 150 must be passed by December 31 of the year before the general election at which it is to take effect.
- (2) If a bylaw is passed in the same year a general election is held, it takes effect at the 2nd general election after the date on which it is passed.
- (3) A bylaw passed under section 143, 148 or 150 must be advertised.
- (4) A bylaw proposed to be made under section 143, 148 or 150 must not be given third reading until after the 60-day period provided by section 231(4) has expired.

Section 231 of the MGA states:

231(1)

Except for a bylaw under section 22, a resolution under Part 15.1 or a bylaw or resolution under Part 17, after a proposed bylaw or resolution that is required to be advertised under this or another enactment has been advertised, the electors may submit a petition for a vote of the electors to determine whether the proposed bylaw or resolution should be passed.

231 (4)

A petition under this section for a vote of the electors on a proposed bylaw or resolution required to be advertised by another Part of this Act or another enactment is not sufficient unless it is filed with the chief administrative officer within 60 days after the last date on which the proposed bylaw is advertised.

(iii) Rationale (examples for & against)

Arguments for this proposal may include:

- there is a cost saving from reducing the number of Councillors (a variable estimate of between \$25,000 to \$30,000 per annum),
- cost savings could be divided between 5 Councillors thereby making recruitment to run for office more attractive to a wider candidate base (in terms of compensation),
- running for Council is becoming less attractive due to an increase in hostility to Councillors possibly leading to a lack of interest in public office.

Arguments against this proposal may include:

- maintaining a 7-person Council provides for 7 opinions and 7 perspectives,
- reducing the number of Councillors could allow a strong minority to dominate meetings and thereby make balanced decisions harder to achieve,
- a quorum of 3 elected officials does not adequately represent the entire municipality.

(iv) Other Information

- a) a \$30,000 saving represents a 3% increase in municipal tax revenues.
- b) in the 2017 municipal election the 6 Councillors who ran for office were all acclaimed.
- c) in the 2021 municipal election 13 candidates ran for the office of Councillor.
 - the highest number of votes cast for an elected official was 247 approximately 20% of the electorate.
 - the lowest number of votes cast for an elected official was 167 approximately 13% of the electorate.
 - the 7th placed candidate received 156 of the votes cast.
 - the 13th placed candidate received 36 of the votes cast.

d) in Town zones east, west and south (source Alberta Munis) 29 out of the 114 Towns have a total of 5 elected officials.

e) the chart opposite provides data on the towns either side of Bowden in terms of population size and the corresponding numbers of Councillors.
 In addition, the Towns of Rimbey and Three Hills are also shown.
