# 6. BUSINESS ARISING FROM PREVIOUS MINUTES

Agenda item 6.a Bowden Hotel

An update on the Bowden Hotel was provided verbally by the CAO.

CAO Rudy Friesen stated that all of the demolition waste material had now been sent to a specialist landfill site and that the current work consisted of infilling the site with compacted clay and topsoil.

It was stated that it is unknown at this stage how long the site must remain dormant pending any future resale of the land by the Alberta Government.

CAO Rudy Friesen stated that he will follow up with the Alberta Infrastructure and obtain further information as to the next steps and procedures regarding this site.

# Agenda item 6.b Annexation of Land

CAO Rudy Friesen provided Council with a brief verbal overview of progress to date regarding the annexation of land from Red Deer County (North of Bowden).

The next stage of the process is for the developer to provide Administration with a draft copy of the "Notice of Intent" document (anticipated by the end of August). If in order the document will then be submitted to the Alberta Government, Municipal Affairs office.

Thereafter the next stage of the annexation process will be to advertise and hold a public hearing within the Town of Bowden.
