Agenda Item 5a – 2022 Operating Budget (Draft 2)

CFO Jacqui Molyneux provided a summary of the revisions made to the first draft of the 2022 Operating Budget and provided Council with a copy of the second draft of the 2022 Operating Budget.

Council discussed, amongst other things, residential property tax revenues, commercial tax property revenues, franchise fee rates, capital v non-capital items, land sale revenues, transfers to reserves and wages.

Motion 5.a Moved by Councillor Randy Brown that: there will be a 0% increase in Residential Municipal Taxes, there will be a 0% increase in Non-Residential Taxes, that there will be a 4% increase in Wages and that the Operating Surplus of \$54917 be transferred to the Reserves-Contingency line within the budget.

The budget remains unpassed. Administration will revise the 2022 Operating Budget as per the motion passed and submit this to Council for final approval.
